Policy initiatives – In the February 2014 Eblast mention was made of great work that NMHOA members are doing at the state level to help strengthen protections for manufactured home owners. This month NMHOA wants to make sure that home owners are aware of some proposed federal legislation that would not be in our best interests. Beware HR 1779 and S. 1828. While the title of these companion bills is "Preserving Access to Manufactured Housing" this title is very misleading. In fact, if enacted these bills would weaken consumer protections, exempt some employees in the manufactured housing lending industry from regulation, and negatively impact the financing options available to people who want to buy manufactured homes. There will be a more detailed article about these bills in our quarterly newsletter, NMHOA Across America, which will be in your in-boxes in the middle of April. Please take the action steps recommended in this forth-coming article.

**Last words for March** – Congratulations to **Ed Green and his co-volunteers in Florida.** Their bill addressing the ever-increasing rents in manufactured housing communities passed out of the House Committee 13 to 0. Best of luck with the next step in your bill's journey towards enactment. Congratulations are also in order for two NMHOA Board members – at its March meeting the NMHOA Board voted to appoint **Tim Sheahan** as President and **Carla Burr as** First Vice President.
