**HUD Office of Manufactured Housing Programs Launches Website for Dispute Resolution Program -**  
*New website will provide education to homeowners and the manufactured housing industry about the Program*

WASHINGTON — The U.S. Department of Housing and Urban Development (HUD) Office of Manufactured Housing Programs (OMHP) has launched [www.huddrp.net](http://www.huddrp.net) — a new website that provides detailed information about the HUD Manufactured Home Dispute Resolution Program (DRP), including educational materials for the manufactured housing industry and homeowners, and information for submitting a request for dispute resolution.

The HUD Manufactured Home DRP provides timely resolution of disputes between manufacturers, retailers and installers regarding the responsibility for correction or repair of alleged defects reported by the homeowner in the one-year period after the first installation of the home. The program is intended to address defects in construction, safety and installation, but does not address cosmetic issues and contractual agreements. Over the past year and a half, OMHP has ramped up its efforts to educate the manufactured housing industry and homeowners about the program. The launch of [www.huddrp.net](http://www.huddrp.net) is a milestone in this effort.

Requests for dispute resolution are typically received from homeowners, but retailers, manufacturers and installers can also submit a request for dispute resolution when involved with disagreements between parties regarding unresolved manufactured home issues. The website explains who can use the program and provides downloadable educational materials about how the process works. Available for download are an illustrative video, a tri-fold brochure and FAQs about the program.
